8. Beverages	water - soda - lemonade - soft drinks - iced tea - fruit/vegetable nectars and juices - fruit beverages (smoothies) - cider - beer - wine - liqueur - spirits - alcoholic beverages - baby food beverages - vinegar - tea/coffee/chocolate if already liquid - syrups (fruit, maple, cordial) - diet and energy drinks - water ice- fruit concentrate (if it's a finished product), citrus oil
9. Oils and fats	vegetable oil (sunflower, peanut, olive) - margarine - minarine - cooking oils and fats - low fat spread - fat powder - mayonnaise - and other sauces with oil (vinaigrette, tartar sauce, pesto)- essential oils
10. Explanation IFS FOOD STANDARD PRODUCT EXAMPLES CHART

General information:

This chart provides examples of products and their allocation with respect to IFS Food product scopes.

These examples only provide keys to understand proper allocation of products and this list does not claim to be exhaustive.

There may be tech scopes mentioned within the product name, e.g. "powdered egg yolk". However, for all products, irrespective of the product scope, the underlying tech scopes also have to be considered e.g. for auditor qualification before auditing a company producing a specific product.

Clarification for vegetarian products (meat analogues):

Typical meat companies producing vegetarian meat analogues do not need the additional product scope 5 and respectively, typical texturized vegetable protein (TVP) manufacturers do not need an additional product scope 1 for producing vegetarian meat analogues.

Clarification for vegan products (vegan cheese analogues):

Dairy companies producing vegan cheese analogues do not need the additional product scope 5 and typical texturized vegetable protein (TVP) manufacturers producing vegan cheese analogues do not need an additional product scope 4 either.

Information about specific rules for choosing product scope 10:

For a company only having mixing and/or packing activities of already dried/powdered products, only product scope 10 should be chosen. As soon as there are any other processing activities, this specific rule does not apply anymore.

Example: if a company has drying activities to produce a "dried milk powder", the fitting product scope is 4 and the above mentioned rule does not apply.

For audits of packing activities under product scope 10 the auditor will not receive a scope extension for any other product scope than scope 10.

Clarification for pet food:

When a company producing food for human consumption also produces pet food, product scope 11 shall be chosen in addition to the other product scopes of the company. This clarification is applicable from 1st of March 2021 (start of the IFS Food version 7).

Clarification about pesto and mayonnaise (under PS 7 and PS 9):

If it's a company mainly producing oil or if the recipe is more similar to oil production then PS 9 shall be chosen. If it's only mixing ingredients then PS7 shall be chosen.
