0 Introduction and objectives

IFS and GLOBALG.A.P. have agreed to facilitate combined IFS and GLOBALG.A.P. Chain of Custody (CoC) audits. Under this cooperation, the IFS auditor, with additional GLOBALG.A.P. CoC training, will assess the GLOBALG.A.P. CoC standard v6 in a combined audit with the IFS Food, IFS Wholesale/Cash & Carry, IFS Logistics, or IFS Broker standards.

The aim of this document is to ensure that the GLOBALG.A.P. CoC v6 requirements are assessed against the above IFS standard requirements in a consistent manner and as part of the IFS Audit.

1 Scope of application

The GLOBALG.A.P. CoC standard v6 generally covers cereals/fresh produce, aquaculture and animal products. The cooperation of the IFS -GLOBALG.A.P. CoC combined audits applies to all IFS Food, IFS Broker, IFS Wholesale/Cash & Carry and IFS Logistics certified companies that process and/or trade products from GLOBALG.A.P. certified production processes (e.g. fruit, vegetables, field crops, fish, seafood, meat or milk).

Further details regarding the products to be certified and certification opportunities can be found on the GLOBALG.A.P. website.

2 Combined audit IFS – GLOBALG.A.P. CoC v6

The GLOBALG.A.P. CoC Standard v6 was published in September 2019 and is mandatory for companies handling GLOBALG.A.P. certified products as of 23 September 2020. CoC assessments are possible in combination with IFS Audits from 1 March 2021.

The IFS GLOBALG.A.P. CoC combined audit will be conducted using the relevant IFS Standard checklist and the GLOBALG.A.P. CoC v6 Checklist. For the GLOBALG.A.P. CoC part of the assessment, the GLOBALG.A.P. CoC Framework v6, the CPCCs (Control Points and Compliance Criteria) and the checklist apply. The GLOBALG.A.P. normative documents are available on the GLOBALG.A.P. website in various languages.

This document shows a detailed comparison between the GLOBALG.A.P. CoC v6 requirements and those of IFS Food v7, IFS Broker v3.1, IFS Cash & Carry v2, IFS Wholesale v2 and IFS Logitics v2.3.

Approval process for IFS accredited certification bodies

Certification bodies wishing to offer a combined audit IFS GLOBALG.A.P. CoC must submit an application to GLOBALG.A.P. The process and requirements are as follows:

- 1. The certification body must be accredited for the respective IFS standard. GLOBALG.A.P. shall receive a copy of the accreditation certificate.
- 2. The certification body shall comply with GLOBALG.A.P. insurance requirements and send its current insurance to GLOBALG.A.P. for verification.
- 3. The certification body must register on the GLOBALG.A.P. CB Extranet at: cb.globalgap.org
- 4. GLOBALG.A.P. checks the IFS approval of the auditors of the certification body. For this purpose, the IFS training documents (IFS approval certificates) are required. The certification body has to nominate one person as CoC In-House-Trainer (IHT). This person must attend a GLOBALG.A.P. CoC IHT training and pass the corresponding examination. During this training the complete facts of CoC are explained control points, general rules and regulations, etc.

You can find an overview of the training on the GLOBALG.A.P. website.

- 5. All auditors who want to conduct combination audits IFS GLOBALG.A.P. CoC have to be approved by GLOBALG.A.P.
- 6. For details on registration costs and other fees applicable, please contact GLOBALG.A.P.
- 7. The certification body enters into a contract with GLOBALG.A.P.
- 8. GLOBALG.A.P. gives the certification body access to the GLOBALG.A.P. database where the certification body registers its auditors. All auditors must complete the GLOBALG.A.P. online tests (OLTs) in the Chain of Custody database before their first audit.

Planning of the combined audit

The site to be assessed must inform its certification body of the wish for an IFS – GLOBALG.A.P. CoC combined audit prior to the IFS Audit. This ensures that sufficient additional time can be scheduled and that the certification body selects an auditor with the appropriate qualifications for the combined audit.

The certification body will request additional information needed for the GLOBALG.A.P. CoC certification process.

The additional requirements checked in the IFS – GLOBALG.A.P. CoC combined audit mean an extension of the audit time, which is to be defined by the certification body.

GLOBALG.A.P. CoC auditor training

Certification bodies must meet the requirements for GLOBALG.A.P. auditor approval. All other aspects regarding the GLOBALG.A.P. auditor training, such as in-house training, training to be performed or exams, is the responsibility of GLOBALG.A.P.

Carrying out the combined audits

Compliance with the requirements of the GLOBALG.A.P. CoC is assessed as part of the audit against the requirements of the equivalent IFS Standard, and integrated into the audit plan accordingly. The sample selected for traceability testing (including mass balance) must be a GLOBALG.A.P. registered product.

During the combined audit, detailed notes on compliance with the requirements of the GLOBALG.A.P. checklist are made and used as a basis for completing the GLOBALG.A.P. checklist. These are to be prepared separately from the IFS Audit report.

Please refer to the GLOBALG.A.P. CoC v6 standard for details on the decision to award GLOBALG.A.P. CoC certification, including assessment guidelines, non-conformities and action plans.

Reporting and certificate

A separate IFS and GLOBALG.A.P. audit report will be issued. After a successful combination audit, an IFS Certificate and a separate GLOBALG.A.P. CoC certificate are issued.

The GLOBALG.A.P. CoC certificate is valid for one year and can be audited annually as part of the IFS Standard assessment cycle. The rules for scheduling the next IFS – GLOBALG.A.P. CoC combined audit and maintaining certification are based on the IFS Standard (i.e. announced or unannounced).

IFS Database

The respective audit reports, action plans and certificates shall be uploaded by the certification body to the IFS Database and to the GLOBALG.A.P. database. Certification bodies wil be able to indicate that an IFS – GLOBALG.A.P. CoC combined audit has been carried out in the IFS Database.

5.9 Management of incidents, product withdrawal, product recall

A procedure shall be implemented and maintained for the management of incidents and potential emergency situations with an impact on food safety, quality and legality. It shall include, at a minimum: • the decision-making process • the nomination of a person, authorised by the company and permanently available, to initiate the incident management process in a timely manner • the nomination and training of an incident management team • an up to date alert contact list including customer information, sources of legal advice, contacts availability • a communication plan including authorities.
